The statement also sets out the circumstances in which you participate in the snorkelling / skin diving programme at your own risk. Your signature on this statement is required as proof that you have received and read this statement. It is important that you read the contents of this statement before signing it. If you do not understand anything contained in this statement, then please discuss it with your dive professional. If you are a minor, this form must also be signed by a parent or guardian.

### WARNING

Snorkelling and skin diving have inherent risks which may result in serious injury or death. Snorkelling and skin diving are physically strenuous activities and you will be exerting yourself during this programme. You must advise truthfully and fully inform the dive professionals and the facility through which this programme is offered of your medical history.

### EXCLUSION OF LIABILITY

Past or present medical conditions may be contraindicative to my participation in the programme. I affirm that I am not currently suffering from a cold or congestion or have an ear infection. I affirm that I do not have a history of seizures, dizziness or fainting; nor a history of heart condition (e.g.: cardiovascular disease, angina, heart attack). I further affirm that I do not have a history of respiratory problems such as asthma, emphysema or tuberculosis. I affirm that I am not currently taking medication that carries a warning about any impairment of my physical or mental abilities.

I understand and agree that neither the dive professionals conducting this program, nor the facility through which this program is conducted, MEGALODON DIVE CENTER, nor Ugo La Sala, nor Nacho Carceles Cros, nor Andrei Novales Palafox, nor PADI Americas, Inc., nor their affiliate or subsidiary corporations, nor any of their respective employees, officers, agents or assigns (hereinafter referred to as "Released Parties") accept any responsibility for any death, injury or other loss suffered or caused by me or resulting from my own conduct or any matter or condition under my control that amounts to my own contributory negligence.

In the absence of any negligence or other breach of duty by the dive professionals conducting this programme, MEGALODON DIVE CENTER, through which this program is offered, PADI Americas, Inc., and all released entities and released parties as defined above, my participation in this snorkelling / skin diving programme is entirely at my own risk.
